

## Kaiser Permanente of Northern California Provider List

**I. Providers Subject to the Medical Financial Assistance (MFA) Policy.** The KFH facilities that share the MFA policy are identified in the MFA policy ADDENDUM, *Section I, Kaiser Foundation Hospitals*. In these cases, provider-patient encounters are subject to KP's Revenue Cycle policies and processes, including application of the MFA Policy.

- a. **The Permanente Medical Group (TPMG).** TPMG providers who are credentialed and privileged/authorized to provide services at KFH facilities for the emergency and medically necessary professional services they render.

**II. Providers Not Subject to the MFA Policy.** Any non-TPMG providers, who are granted privileges at KFH facilities, are requested to perform emergency and medically necessary professional services and bill the patient directly. This includes dental services provided in conjunction with, or incidental to, emergency or medically necessary services. In these cases, the potential exists for patients to receive a bill directly from the provider. Such direct billing would not be subject to the MFA Policy.
